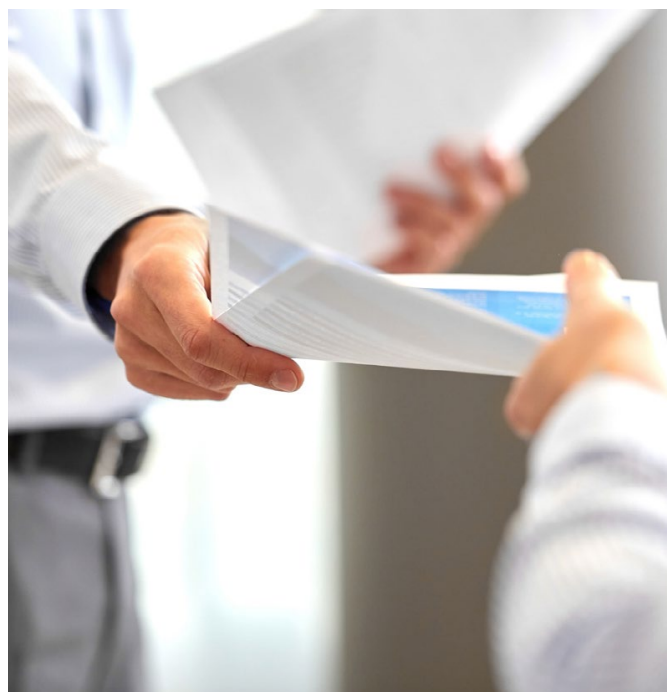

Data Protection Management

The protection of personal data of our employees and business partners is of great importance to Rutronik Elektronische Bauelemente GmbH. For this reason, we process personal data exclusively in accordance with the relevant legal provisions and are guided by the EU data protection principles when handling personal data. We extend these principles to the entire Rutronik Group. This means that personal data is also processed properly and in compliance with the applicable laws at each of our subsidiaries.

We know that data protection cannot only be guaranteed technically by IT, which is why we also rely heavily on organizational measures. We regularly train our employees on the topic of data protection and have created an internal contact point for data protection issues and topics in addition to our data protection officer. The latter supports employees in processing personal data in compliance with data protection regulations and monitors compliance with the rights of data subjects.

Fire Protection Management

Our fire protection measures comply with legal regulations and requirements. This includes preventive, structural, technical and organizational fire protection in equal measure. The effectiveness of our fire protection concepts is reviewed and evaluated at regular intervals by fire protection experts. Findings and deviations are dealt with and optimized as part of a continuous improvement process. Our employees undergo annual training in the areas of occupational safety and fire protection and are also made aware of these issues as part of escape and evacuation drills.
